Established over 30 years ago with a vision to create a bank that would serve the needs of its customers and

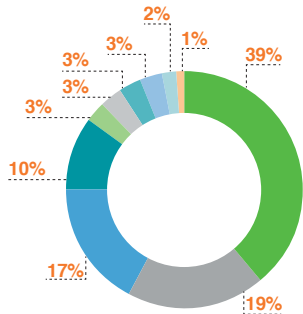
enrich society, our purpose is to help organisations to prosper, and contribute to economic, community, and environmental change.

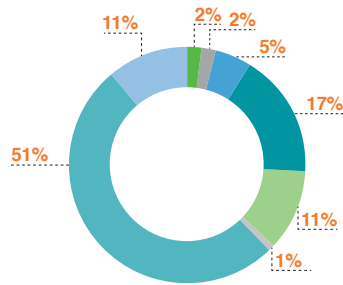

Borrowers by legal status



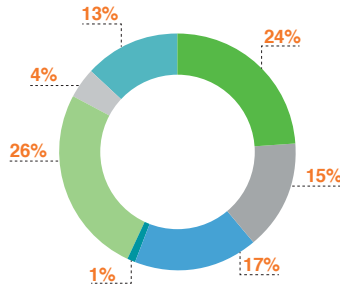

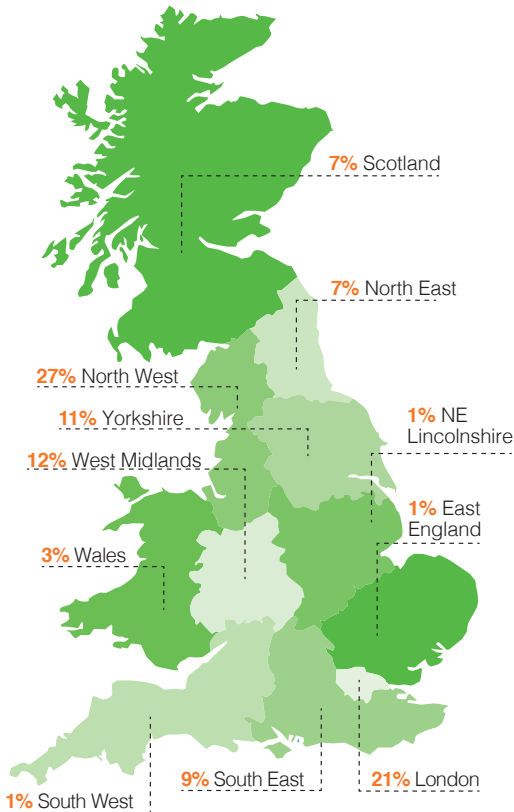
